### Annual Ecclesiastical Meeting of Trinity Presbyterian Church (U.S.A.) Cherry Hill, New Jersey February 12, 2023

The sixty-fifth Annual Ecclesiastical Meeting of the organization of Trinity Presbyterian Church (U.S.A.), Cherry Hill, New Jersey, was called to order by the Moderator, the Reverend Dr. Gregory C. Faulkner, on February 12, 2023, at 10:26 a.m. in the Sanctuary. Dr. Faulkner opened the meeting with prayer. The Clerk declared that a quorum was present.

It was voted to **approve** the minutes of the Annual Ecclesiastical Meeting of February 13, 2022 and the Congregational Meeting Minutes of May 22, 2022 and December 18, 2022.

#### ANNUAL REPORT APPROVAL

Rev. Dr. Faulkner presented the Annual Report which had been distributed to the congregation in digital and physical copies prior to the meeting. There being no questions or discussion, a **motion** to accept the Annual Report as written was **made**, seconded, and the **vote carried**.

### TERMS OF CALL 2023

Rev. Faulkner recused himself from the meeting.

The Clerk presented the **2023 Terms of Call for Reverend Dr. Gregory C. Faulkner** (as found in the annual report):

There was a **motion** and **second** to accept the terms of call of Rev. Faulkner as recorded in the annual report. The motion **carried**.

### Annual Corporation Meeting of Trinity Presbyterian Church (U.S.A.) Cherry Hill, New Jersey February 12, 2023

The sixty-fifth Annual Meeting of the Corporation of Trinity Presbyterian Church (U.S.A.), Cherry Hill, New Jersey, was called to order on February 12, 2023, at 10:35 a.m. in the church Sanctuary by the President of the Board of Trustees, Brad Ritchie. The closing prayer of the Annual Ecclesiastical Meeting, delivered by Rev. Dr. Gregory Faulkner, served as the opening prayer.

The Clerk confirmed to the President of the Board of Trustees, that a quorum was present. A **motion** to accept the minutes of the Corporation Meeting of February 13, 2022 was presented by the President, was **seconded** and **approved** by voice vote.

Elder Nancy Roberts presented the slate of new members for the Board of Trustees:

The President called for any additional nominations from the floor. There being none, a motion was made and seconded that the slate be accepted. The motion was **approved** by a voice vote.

The President dismissed and thanked the Nominations Committee: Chair, Elder Cosmo Digneo, Elder Audrey Azevedo, PW Moderator, Barb Clarke, Rev. Dr. Gregory Faulkner, Elder Beth Gammie, Karen Kain, outgoing PW Moderator, Carolyn Kramer, Elder Nancy Roberts, Deacon John Smith, and Deacon Michele Strobel.

The Audit Committee Convener, Linda Wean, presented the report of the 2022 Audit Committee. The Committee included herself and John Smith. They met with treasurer, Debby Talbott, on November 22, 2022 to perform the 2022 audit based on a sampling of financial transactions.

The committee reports that the records are accurate, in good order, compliant, and reflect the requirements in the procedure manual. Additional information appears in the committee's report. The committee acknowledged and thanked church treasurer, Debby Talbott.

There being no questions or comments, a **motion** was made and **seconded**, to accept the Audit Report, which was **approved** by a voice vote. The President dismissed the Audit Committee with thanks.

Mr. Ritchie then briefly commented on the 2022 financial reports included in the Annual Report. The 2022 budget results and 2023 budget were reviewed and discussed at the January 29, 2023 budget forum, and the budget was **approved** by the session on that day.

The President noted that the 2023 budgeted pledge target is \$10,000 less than last year and that 2023 projected expenses included the assumption of six months of salary for a new associate pastor. Elder Ritchie stressed that total income alone was not sufficient to balance last year's operating budget. The transfer of \$20,000 from the manse fund and \$41,935 from the operating fund was required.

Follow-up questions were answered. Mr. Ritchie thanked the Finance Committee members: Cosmo Digneo, John Young, Donna Croker, Church Treasurer, Debby Talbott, Rev. Dr. Gregory Faulkner, and Rev. Ms. Sarah Craven.

Mr. Ritchie then asked for any Old Business that needed to come before the Corporation. Hearing none, he asked whether there was any New Business. There was none.

Upon a **motion** being made and **seconded**, it was **voted** to adjourn the meeting at 10:50 a.m., and Rev. Faulkner offered the closing prayer.

## Personnel Committee

During 2023, Trinity was blessed to have a dedicated staff who continued to serve our congregation with passion, dedication, and faith. Personnel Committee members for the 2022-2023 Church-year were seated-Elders Donna Croker '24, who served as chair, and John Young '23, along with at-large members Nancy Valente '23, Margery Sly '24, and Peter Bowman '25. Much of the work of the Personnel Committee (PC) is confidential, by its nature.

Our Senior Pastor, The Reverend Dr. Gregory Faulkner continues to lead, inspire and guide our congregation with the help of our clergy, office staff, and volunteers from the congregation. His management of these essential resources has been critical for maintaining Trinity's vital ministry. Greg spends a large portion of his time connecting with church members. He also leads weekly in-person and live-streamed worship, and works with his church team.

The Personnel Committee establishes performance goals for Reverend Faulkner in the areas of preaching and worship, teaching ministry, stewardship, leadership of staff and lay leaders, and leadership development. To help achieve these goals, Reverend Faulkner dedicates one day per week to solely study for sermons and educational offerings, led a weekly Bible study, worked with the Whole-Life Giving Committee to support Trinity through estate planning, spent time with Session and Deacon members, and developed mentoring relationships with younger members of the Church.

Our Associate Pastor, The Reverend Sarah Craven, continues to work with Reverend Faulkner and Church members. She supports Trinity activities, Children's Education, and Mission. Sarah also assumed the responsibly of connecting with sick or elderly members, who were previously visited by Reverend Barry Gruver until his retirement from Trinity in July 2023.

For the 2022–2023 Church year, performance goals were established for Sarah in the areas of pastoral support to Trinity Members and connecting with the Community, Children's Ministry, and Mission. To achieve these goals, Sarah met with Trinity's college students, lead and participated in the Sunday School Program, with the support of the Children's Ministry Committee, and also provided outreach to Trinity members who no longer can attend in-person worship services.

We are grateful for the ministry of Reverend Barry Gruver, who served as our part-time Parish Associate until his retirement in July 2023. Reverend Gruver primarily provided outreach services, supporting the sick and elderly. He also assisted in our worship on many Sundays. He will be greatly missed as will his loving ministry of care to so many in our congregation.

We are very grateful for the enthusiasm, creativity, and energy of Lisa Marcelli, our Music Director, and Brian Kain, our Music Associate, as they work with our children's choirs, adult choir, hand-bell choirs, and instrumental groups. Participation in all of the musical programs has continued to grow and is extremely vital to Trinity's Ministry.

Our dedicated office staff continues to support our clergy and congregation. Sue Nork, Trinity's Office Manager, worked full-time managing and performing numerous office functions until her retirement in May 2023. We are grateful for her over 20 years of service to our congregation. Sue was a vital part of supporting the many ministries of Trinity. In a connectional church Sue helped us stay connected.

Alysia Sieh Badskey, who previously worked two days a week as Media Specialist, assumed the consolidated position of Trinity Office Manager and Media Specialist. Alysia has provided many innovative changes, which have contributed to the efficiency of the office tasks.

Membership Associate, Pam Dougherty, works two days per week supporting a variety of office functions with a focus on Membership, helping with visitor documentation and pastoral ministry.

Our Treasurer, Debby Talbott, is another trusted full-time member of the office staff. With the help of the Finance & Stewardship Committee, Debby manages financial issues and Trinity's investments.

The Personnel Committee strongly encourages the staff to seek opportunities that contribute to their professional and personal growth. The Committee is also responsible for providing the staff with the resources they need to effectively and efficiently perform their responsibilities. During 2023, computer upgrades were made, as necessary.

Trinity's leadership determined in 2022 that additional initiatives to develop more diverse and engaging programs and mission, improved member support, and enhanced community outreach was necessary. An Associate Pastor Nominating Committee (APNC) was formed and continued to meet regularly throughout all of 2023 working towards the calling of an additional Associate Pastor.

A representative from the library committee is available most Sundays after services for any questions, comments, and/or book suggestions.

- New and/or seasonal books are prominently displayed throughout the library with signage indicating such.
- Data entry of every piece of media to an online card catalog program (LIBIB.com) was completed by mid-summer. The system is up and running for all congregants via the website <a href="https://www.libib.com/u/trinpresch">www.libib.com/u/trinpresch</a>.
- An updated description of the library, how to check out books, and the online system that is being used was provided so the church website would remain current.

## Presbyterian Women Annual Report - Jenny Foley, PW Moderator

The PW's purpose includes nurturing our faith through prayer and Bible study, supporting the mission of the church worldwide, working for justice and peace, and building an inclusive, caring community of women. We always encourage new members to become part of our community of women working and learning for Christ. Please speak to any member of our board if you are interested in learning more.

Thank you to our wonderful PW Coordinating Team, without whom I would be no more than a lost little puppy. We are grateful for the support of the Session. We are blessed to have pastors Rev. Craven and Rev. Faulkner to lead us and help us nurture our faith. We would not have been able to maintain our programs without the help of Alysia Sieh and the office staff, Lisa Marcelli and her musicians, and the Trinity Production Team. We are so very grateful to you all.

We have had a very busy, productive year.

- Our PW Board was continued in Jan. 2023 under the leadership of Barb Clarke, whose theme of "Mustard Seed Moments" was greatly welcomed and appreciated by all who viewed the wonderful video segments on our YouTube channel.
- Our Mission Representatives have reported that this year's total donations, monetary and non-monetary, exceeded \$10,000. This report is also submitted to the Mission & Outreach Committee of Session.
- Throughout the program year, our Circles collected money and made donations to many local charities, including the following: the Cherry Hill Food Pantry, the Military Support Group of NJ, SistaTalk PHL, R&M Boarding Home, and several others. Each of the Circles also contributes to the Least Coin, Birthday, and Thank Offerings, which are sent to the PW National organization throughout the year.
- Our largest mission project is our own Care and Share Thrift Shop. At the end of this year, our balance is over \$28,000!! Many of the same organizations mentioned previously have benefited from our contributions, as well as some others, including Cathedral Kitchen, Unforgotten Haven, Caring Hearts Ministry, and several more. Care and Share is a vital part of Trinity's mission to help our community.
- Throughout the year, our Publicity Committee has maintained and updated the PW bulletin board (located near the mini-elevator) to reflect our current activities, as well as the season.
- Our PW currently has six Circles, who meet at various locations and times. This information can be located in each Sunday's Work and Worship portion of the bulletin, on the PW bulletin board, or by reaching out to any member of the PW board. Some Circles meet in-person, some meet online, and some utilize both methods of interaction.
- Gifts of Women Sunday took place on March 5, 2023. Many PW volunteers participated in the service in various roles. During the service, the PW Honorary Life Membership Award was presented by moderator Barb Clarke to Donna Croker for all of her years of service and dedication to both the PW and to Trinity.
- We held our annual PW Retreat on April 21 and 22 at Trinity. Friday evening included a casual pizza dinner, followed by guided meditation. On Saturday, Pastor Sarah (fresh from Maternity Leave) led our group in prayer and Bible study. Several stations were set up, at which the ladies participated in different activities.
- On May 2, 2023 we held our Spring Installation and Dinner, here at Trinity.We installed our new members and thanked several members who continued to serve in their same or different capacity on the board. We also thanked our departing members for their service. Our guest speaker for the evening was Ellen Shimburg from Project Rozana. At the end of the night, a donation of over \$700 was made to the organization, which works on bringing peace to the Middle East by building better understanding between Israelis and Palestinians through health. Our new moderator was installed, Jenny Foley. Her theme for the new program year was "Inclusivity and Diversity."

- In October we recognized Pastor Appreciation Month and our pastors' service by giving them each a small gift card for their use. Additionally, a poem was written and read to the congregation by Jenny Foley during the morning worship service on October 8.
- Our Fall Gathering was held on October 10. We had an Indian Culture fashion show, along with Telugu Christian worship songs. We raised \$375 for the Vicente Ferrer Foundation USA. 40 women attended this wonderful evening.
- The PW Cookie Sale was held in church during Coffee Hour on December 3. We were able to raise an unbelievable \$695 to put toward PW programs and missions due to the overwhelming generosity of our wonderful congregation!!
- The annual PW Advent Dinner and Candlelight Service was held on December 5. A delicious dinner was catered by Cathedral Kitchen, followed by a beautiful service, led by Pastor Sarah. 50 women attended the dinner, with more joining us for the service. \$501 was raised for the Center for Family Services Mother and Child Residential Services in Camden County.
- The PW Programs Committee has really knocked it out of the park this year with their dedication, creativity, and hard work. Audrey Azevedo, Carolyn Fletcher, Georgeanne Moore, and Trudie Levins deserve a tremendous amount of praise for their work this year.

### Presbyterian Women Financial Report 2023

## **Children's Ministries Annual Report -2023**

The Children's Ministries committee runs the church school from nursery age through 5th grade. This year was the first year 6th grade transitioned to the middle year program. The committee consists of Liz Nieradka (session) chair, Michelle Yeary (session), The Reverend Sarah Craven, Linda Craven (coordinator of church school), Nancy Roberts, Janelle Curl, Gary Naumick, and Ben Rieth.

We continued with our Church School weekly rotation schedule for the 2023 program year. This allowed children to participate in a variety of ways which included mission projects, worshiping with family, and with traditional church school lessons. Highlights from our program year are shared below.

- Mission projects created by the elementary age children during Mission Sundays included: creating centerpieces for Cathedral Kitchen, Easter cards for the R&M Boarding Home residents, Placemats and utensil bags for Cathedral Kitchen, and hygiene bags with supplies collected by PW.
- Monthly Family church provided opportunities for community among Trinity families. Lessons included many hands-on activities for children such as the creation of a mural of God's world and crowns and cake for Three Kings Day.
- Trinity continues to provide traditional Sunday School classes. Grades 1-3 uses the *Spark Curriculum* and grades 4-5 uses *Be Bold*. The nursery school class uses the *Beginner's Bible Timeless Children's Stories* and for Bible stories and crafts. We continue to work to recruit new parent volunteers who are willing to help teach or assist in a classroom. The committee has used Signup Genius to establish coverage for the classes each week. Nursery care is provided each week as well. We were also able to organize coverage for nursery care for the summer months for the younger children.
- Events run this year by the Children's Ministries group included the annual Pancake Breakfast, the Advent Festival and the Palm Sunday Festival. Our committee also provided children's crafts at the Fall Festival of Thanksgiving.
- We continued with our Family Fun Day traditions at the end of April this year. This event included the annual cupcake contest, a luncheon, Mister Softee, and games. A new event was a bubble gum blowing contest that included Rev. Faulkner, Rev. Sarah Craven, Lisa Marcelli, and Brian Kain.
- The committee began work on the nursery school office cleanout and with the help of Lisa Marcelli, Alysia Badskey, Karan and Rusty Sieh, Nancy Roberts and Susan Bastnagel. Karan and Rusty Sieh were instrumental in running the Freecycle event in early December, where many of the toys and school supplies from the nursery school were donated to local community members, teachers, and preschools in other communities.

Thank you to all the wonderful teachers, helpers, and volunteers who help run our church school programs. Special thanks to Linda Craven who checks in on the classes each week and often covers classes when needed.

# <u>Finance & Stewardship</u>

The Finance & Stewardship committee would like to thank everyone who donated to Trinity this past year. 2023 was a rebound year for our investments and our income was consistent throughout the year. Our expenses were well under our budgeted amount due to the fact that a 3<sup>rd</sup> pastor was budgeted for the last half of the year, but did not happen. Our committee meets monthly on Zoom and the committee members are Greg Faulkner, Sarah Craven, Debby Talbott, John Young, Donna Croker, AnnMarie Palatnik and Brad Ritchie. The committee's primary responsibilities include, preparing the budget, perform financial transactions, manage contractual obligations, manage church investments, annual Stewardship Campaign, provide direction to Church Treasurer, coordinate with Church Board of Trustees and church committees and provide information to church membership.

- We saw 14 new pledges from new members who have joined Trinity in 2023.
- Per Capita from our members was stronger than last year however we are still well short of what we need to send to Presbytery.
- We spent approximately \$38,000 in capital projects in 2023. In addition, we had another flood downstairs but due to fast action from Property and Buildings committee, the damages were not extensive, and costs were held to approx. \$12,000.
- Due to mold issues at Witherspoon, it was decided to stop using the building and turn off the electric and water which will cut our expenses going forward. A committee has been set up to look for options for the building and possible uses.
- As stated above, our investment returns have improved compared to 2022. While we do not yet have final numbers for 2023, it is expected that the returns will offset what we withdrawal to balance our budget.
- The individual committees have once again done a wonderful job of managing their budgets.
- Our cash flow was very consistent throughout the year. In the past, we had a "summer lull" where our income decreased throughout the summer months. Since more members and now using EZ Tithe, the income is becoming much more consistent making cash management much easier.
- Our stewardship campaign this year is **Hearts to God, Hands to Serve**. The committee would like to sincerely thank Dipal Willoughby, Judy Spotto, and Jennifer Peelman who spoke to the congregation in the 3 weeks leading up to Stewardship Sunday. Brad did the final wrap-up in what appears to be a successful stewardship campaign.

# **Membership** Committee

The Membership Committee is delighted to report that we welcomed 22 new members in 2023! Our membership count as of December  $31^{st}$  is 602.

Membership associate Pam Dougherty periodically reviews our membership rolls to identify members who haven't attended worship (or otherwise been in contact) in several years, despite outreach efforts. Our current membership count reflects the mid-year deletion of about 20 members who hadn't attended in more than three years. It also reflects the deletion of about 30 college-age and adult children of members; these young people rarely or never attend worship, many because they now live out of state, and their parents agreed to their deletion from the rolls. This effort makes our membership count more accurate and reduces Trinity's per capita obligation.

Activities hosted by the Membership Committee in 2023 included:

- Three Membership Information Sessions. These sessions are informal opportunities to learn more about what it means to be a Presbyterian, and about all of the wonderful opportunities that Trinity offers for worship, fellowship, and learning.
- A new member luncheon Traditionally hosted annually by the Faulkners at their home, we hadn't had a new member luncheon since before COVID. We decided this year to invite everyone who had joined since then to a luncheon in the Community Room. It was well attended and lots of fun.
- The Rally Day picnic This year's Rally Day picnic saw the highest attendance since well before COVID. Many pitched in to make the day a success.
- The Fall Festival of Thanksgiving—Organized by the Membership Committee, this event involved a number of groups. The Sunday Morning Men's Fellowship Group hosted the Chili Cook-off. PW organized the Tombola Basket Raffle. Youth Ministries had a "Decorate Your Own Cupcake" table and Children's Ministries had plenty of fun Fall Crafts for the kids.
- Our annual Nativity Walk—Thanks to all who participated in what has now become an annual Advent tradition at Trinity. Roseann Frielink again played Christmas carols on the piano during the event. And there was cake!
- The Christmas Eve social The 2023 social featured a delicious Christmas punch and lots of treats and was VERY well attended.

The 2023 annual review of the Trinity Mission Statement was conducted with Michele Strobel from Deacons and Jan Cafferty from Presbyterian Women. No changes were suggested to the Mission Statement. We were doing a good job in the physical area of our statement and the REAP Committee was addressing some of the spiritual and civil concerns in our statement. ### **CROP Hunger Walk (Community Responding to Overcome Poverty):**

- The annual CROP Walk was a great success. It included a kid's walk and a pet blessing for the first time. There were approximately 25 walkers. We exceeded our goal of \$1000, raising \$1400 (\$350 for the Cherry Hill Food Pantry) for the global mission of the Church World Service to assist hunger-fighting agencies globally to bring hope to those in need.
- Special thanks to Chris Bryfogle for coordinating this activity and assuring its success on behalf of Mission and Outreach.

### Care 'n Share:

Care n Share has been in operation since 1976. It began as a clothing drive for Trinity's "white gifts " recipients. It was decided that a shop could be a mission by offering clothing & housewares at "garage sale" prices to the general public.

It is run by approximately 20 Trinity volunteers who spend about 3 hours a week marking & displaying all of the donated items. \$18,500 was donated out in 2023 to the following recipients: Cherry Hill Food & Outreach Council, Cathedral Kitchen, Volunteers of America, Urban Promise, Interfaith Homeless Outreach Council(IHOC), Seeds of Hope, Unforgotten Haven, Caring Hearts, Angels of God, Johnsonburg Presbyterian Camp & Conference Center, StandDown (Homeless Vets), Presbytery for South Jersey Disaster Relief, Trinity Senior Highs' Work Trip.

- We are grateful to the dedicated volunteers that run the Care 'n Share Shop and to those who have contributed the many items (e.g., clothing, household items) that make the Shop an important resource to the local community. Business was strong this year. The Shop and parking lot are always a buzz with activity when it is open to the public.
- Special thanks to Eileen Rankin for coordinating the activities of Care 'n Share.

## **Board of Deacons – Michele Strobel, Moderator**

According to the by-laws of our Church, the Board of Deacons is comprised of men and women who serve three-year terms. The Deacons are responsible for service, fellowship, visitation, and outreach to the congregation and community. While each committee is chaired individually, all members are expected to participate across all responsibilities. The Board of Deacons is extremely appreciative of the congregational support - for their generosity in giving of their time, gifts, and financial contributions.

#### Assistance and Outreach Committee – Judy Spotto, Chair

- **Spring/Fall Blood Drives:** held in the Spring and Fall to benefit American Red Cross. This year both drives exceeded their collection goals. All from the congregation and community are welcome to participate.
- Summer and Winter Food Sharing Programs: The Deacons purchase food and household items from ShopRite of Cherry Hill (out of the Deacon fund) for Urban Promise and Acenda Health (Robin's Nest).
- School Supply Collection: A congregation-wide collection to benefit Urban Promise.
- Fall Coat/Blanket Drive: New or slightly used coats were donated by the congregation and Care n Share. They were donated to R&M Guest Home, Little Hands Little Feet, Cathedral Kitchen, and Joseph House.
- Christmas Toy Drive: Unwrapped gifts and gift cards were collected for Urban Promise's Promise Store. The Promise Store offers parents the ability to choose Christmas presents for their children, offering dignity and personal selection.
- Acenda Health Uber/Lyft Gift Card Drive: Deacons added a new gift card drive this year to benefit Acenda Health clients young adults who have aged out of support systems and need assistance with transportation getting to work, counselling, medical appointments.

#### Fellowship Committee – Alison Schwarz, Chair

- Responsible for setting up and providing the Coffee Hour each Sunday.
- Keep the supplies inventoried and stocked appropriately in the upstairs kitchen, as well as general oversight of the urns and other appliances required for Coffee Hour.

#### Service Committee – Kelly Murray, Chair

- Ushering: Four Deacons volunteer weekly to set-up the narthex, greet congregants and guests while giving a service bulletin, and provide guidance as needed. These ushers also take a count of all attendees during the service, collect the offering and deposit it in the office safe, and collect the signed pages from the registry books after the service while confirming the sanctuary is cleared of any debris and reorganized as needed. If it is a Communion Sunday, either two Deacons (for intinction) or four (for the passing of the plates) assist the pastors with serving the congregation.
- **Communion:** Two Deacons prepare trays of gluten-free bread and 100% grape juice for communion. They are also responsible for setting up the Communion Table before the service and clearing/cleaning it afterwards. Pre-packaged Communion kits are still available and are offered before the service in the Narthex for members who prefer to receive this way.

#### Visitation Committee – Janelle Curl, Chair

• Coordinates weekly flower deliveries to those church members who are sick, homebound, or grieving, as well as celebrating joyous occasions. Many deacons also take copies of the bulletin and a small wooden cross to the recipients.

## **Property and Buildings Committee**

The P&B committee is responsible for maintaining the church property and grounds. Our budget includes the cost to cut the grass, remove leaves, snow removal and salting, janitorial services, making repairs, electric and gas for heating and cooling the buildings, water and sewer costs, waste removal, building inspections for fire alarms, elevator, and kitchen as well as insurance. These costs are fixed costs that we monitor and strive to minimize where possible.

2023 has been a busy year for the committee. Some of the larger projects that were completed include

- Repairs and cleanup after the Flood we had on July 4<sup>th</sup>
- Fire alarm horn strobe replacement throughout the building
- Office security door installation
- Front step's wrought iron hand railing replaced
- Commercial Refrigerator and freezer replaced with household units
- Steeple cleaned and painted
- Lights and fire alarm batteries replaced
- Water monitor installed so we can identify water leaks and reduce waste
- Repainted the office conference room
- Closed Witherspoon after mold was discovered.

As the church ages, the number of things that need to be replaced or repaired increases. We had planned to replace the front exterior stairs near the office and the center stairs, however the church's financial position would not allow us to proceed. We had also planned to replace many areas of sidewalk that have cracked, chipped, or sank but again the finances would not allow.

Because of reduced attendance, the Sunday school classes were relocated to the main building, so there has been limited use of the Witherspoon building. After the July 4<sup>th</sup> flood we found that there were mold spores in the air. It was decided to close the building and move the few groups that used it into the main building. At this time there isn't justification to invest the money to remove the mold and fix up the building. We are looking for ways to utilize the building and justify spending the money necessary to make it desirable.

## **Strategy Committee**

The Strategy Committee consists of the chairs of each of the Session committees and the Clerk of Session. This structure allows all areas of the church to have input into our strategic direction. This approach also provides the diversity needed to properly prioritize initiatives and resources.

- Financial and personnel issues
- Stewardship campaign
- Budget creation and adjustments
- New or revised fiscal and administrative policies

During 2022, the Committee approved the following capital expenditures:

- Refurbishment of the bells and chimes
- New cases for the bells
- Replacing water gauges for the fire suppression sprinkler system to comply with fire codes
- A new computer for pastoral and office staff

Volunteers are critical for the success of Trinity's programs and mission. The Strategy Committee recognized the need for additional volunteer resources from Church members and is considering a Volunteer Stewardship campaign. To prepare for this campaign, the Committee developed a list of Church activities (current and future) that require volunteer support and defined the skills needed and time commitment for each program/ initiative.

## **Worship and Music**

The Worship and Music Committee included Bonnie Jones (chair) and Roseann Frielink. We meet throughout the year with Lisa Marcelli and Rev. Faulkner to discuss issues related to the music program and worship in general such as communion, baptisms, and flowers.

We have once again begun to have sign-ups for memorial flowers. The flowers are displayed in the Narthex and then delivered to shut-ins after the service.

On World Communion Sunday we provided the congregation with breads from other countries. They were displayed on the communion table with cloths from around the world. Later they were sampled in the community room.

Reverand Dr. Faulkner and Reverand Craven both celebrated ordination anniversary milestones this year. Reverand Faulkner celebrated 30 years and Reverand Craven celebrated 15 years. We are thankful for their years of service in the ministry!

### Music Department Report – Lisa K. Marcelli, Director of Music

Thank you for another year of wonderful music at Trinity! The many musicians at Trinity continue to work hard to present music to praise God. I am grateful for the support of the congregation and staff. The music community at Trinity is strong and the door is always open for new members.

- There are, at present, 12 musical ensembles at Trinity; 8 rehearse weekly.
- Highlights would be the Advent Services, Holy Week, the Children's Musical <u>Moses and the Freedom</u> <u>Fanatics</u>, Youth Sunday, Music Dedication/Stewardship and the newly added Spiritual Sunday and World Communion Sunday.
- The 5 Lenten Soup and Sound concerts were well attended with the help of organizers Audrey Azevedo, Bonnie Jones and Nancy Roberts.
- The 2023-2024 Trinity Community Concert Series is celebrating its 33<sup>rd</sup> season with Linda Flanary, Carolyn Kramer, Kristen Viglietta and Ron Willoughby serving on the committee. The Atlantic Brass Band and the Last Whipporwill Band will perform.
- Trinity's musical instruments continue to be maintained and are in good working order. 8 octaves of bells and 3 octaves of hand chimes were sent to be cleaned and refurbished this summer.
- As part of the Negro Spiritual Royalty Project Worship and Music donated \$310 to Play on Philly, an organization that provides musical education in Philadelphia school communities that are historically excluded. Thank you to the Mission and Outreach committee for their guidance on this new project.
- The Rejoicing Ringers provided community outreach again this year when the performed at the December Garden State Chorale concert.
- The choral and bell music continues to be overseen by librarians Dave Large and Pam Dougherty
- In addition to the weekly reporting of all Sunday music copyright for livestream, with the help of Alysia Sieh Badskey, we have moved over to a cloud-based system for our weekly music records and have created a virtual database.
- The Music Support Team, with Doug Nork as leader, continues to serve by facilitating the moving of equipment for various Sundays during the year.
- Susan Bastnagel continues to support the music department with TCCS PR as well as designing multiple music videos and all around tech support for new ideas such as the virtual Christmas Countdown.
- Kira Mahoney continues her work helping with music social media
- Brian Kain and Julia Wilson continue to work as support staff to the Director of Music.

- We transitioned the youth over to the main building from Witherspoon. While it is still a work in progress, we're thankful to those who donated furniture to help make the room more comfortable.








## 2023 Audit Committee

The Audit Committee for Trinity Presbyterian Church (USA) elected at the Annual Corporation meeting consisted of Bill Kain, John Smith and Linda Wean. Using the Audit Steps template developed by the 2013 Audit Committee, the 2023 committee met with Treasurer Debby Talbott on December 6, 2023, to conduct the audit. A review of the latest updates to the Book of Procedures was completed as well as the 2023 audit based on a sampling of the financial transactions from the current year.

- The Book of Procedures was updated and approved by the Finance Committee on 10/12/2023. This was verified by the Audit Team.
- Easy/Tithe receipt were reviewed and verified. No discrepancies or inconsistencies were found.
- Giving records, check deposits and bank statements for January 26, 2023, June 16, 2023 and October 18, 2023 were requested for review. No discrepancies or exceptions were found.
- All checks over \$2,000.00 for the first quarter (Jan., Feb., March 2023) eleven were reviewed 8 had back-up signature and 3 were recurring monthly. All were done following procedure.
- Reviewed all credit cards bills for the month of July 2023. All agreed and had supportive documentation.
